Membership in the Republican Party of Garland County (RPGC) is a two (2) year "elected position" and requires the payment of a Filing Fee because you are seeking an elected office as a Committeewoman or Committeeman. Individuals desiring to be elected to the County Committee of the RPGC must complete this Filing Form and pay a Filing Fee of \$50.00 in either cash or check made payable to the Republican Party of Garland County (RPGC).

## Duties of County Committee Members

County Committee members shall be responsible for canvassing and organizing their respective precincts, appointing captains, recruiting qualified Republican candidates, raising party funds, identifying qualified poll workers, assisting the officers of the County Committee, and supporting and working to elect Republican candidates.

## Duties of the County Committee

The County Committee shall make every reasonable effort to accomplish the objectives of the Republican Party of Arkansas, maintain sufficient funds to conduct party activities, procure and elect qualified Republican candidates, and conduct affairs of the County Committee in such a manner as will result in respect by the electorate.

The following **Objectives** and **Principles** are contained in the PREAMBLE to the rules of the Republican Party of Arkansas.

## Party Objectives

The Republican Party of Arkansas declares its objectives to be:

- 1. The election of qualified Republican candidates to every public office, and
  - 2. The fulfillment of the needs of the citizens of Arkansas in a manner consistent with the beliefs and principles of the Republican Party.
